Verses 20–23: The psalm concludes with a declaration that God will bring justice against the wicked and uphold the righteous. The final verse affirms that God will not abandon His people but will repay evildoers according to their deeds, ensuring ultimate vindication for the faithful.

Key Themes

One key theme is the certainty of divine justice. The psalm emphasizes that God is fully aware of human actions and will not allow wickedness to go unpunished. Another theme is the tension between the apparent success of the wicked and the eventual vindication of the righteous, highlighting the need for patient trust in God's timing. The psalm also



explores the theme of divine discipline as a form of loving correction, showing that God's chastening is meant to protect and guide His people. Finally, the theme of God as refuge and counselor underscores the personal relationship between the believer and God amid trials.

Cross-References
