Verse 7: The psalm concludes with a vivid image of the adversaries' hostility likened to sharp arrows and burning coals. This metaphor captures the pain and danger inflicted by their words and actions, leaving the psalmist wounded and in need of divine protection.

Key Themes

One key theme is the power and danger of deceitful speech, which can cause deep emotional and spiritual harm. The psalmist's experience highlights the destructive impact of falsehood and duplicity within community life. Another theme is the longing for peace amid conflict, reflecting the tension between the desire for harmony and the reality of hostility. Trust in God as the ultimate deliverer is implicit throughout, as the psalmist turns to the Lord in distress, seeking protection and vindication. Finally, the metaphorical language of arrows and burning coals emphasizes the intensity of opposition faced by the faithful.

Cross-References

Psalm 120's cry for deliverance echoes the plea in Psalm 34:17, where the righteous call out and the Lord hears them. The theme of deceitful speech resonates with Proverbs 6:16-19, which condemns lying lips and false witnesses. The longing for peace amid hostility parallels Jesus' teaching in Matthew 5:9, where peacemakers are called blessed. The metaphor of arrows recalls Ephesians 6:16, where believers are encouraged to take



up the shield of faith to extinguish the flaming arrows of the evil one. These cross-references deepen understanding by situating Psalm 120 within the broader biblical narrative of trust, conflict, and divine protection.

Application
